(1) INTRODUCTION:

The meeting commenced with Sergio welcoming members, and introducing the guests who joined for this meeting.

(2) BUSINESS ARISING FROM PREVIOUS MEETINGS:

Minutes of Meeting #127 were approved with no changes, motioned by Gordon Dalzell, and seconded by David Thompson.

(3) UPDATES

The following updates were provided:

- Boil Off Gas (BOG) Liquefaction Project is experiencing minor delays due to challenges with vendor selection and long lead times.
- Mobility in the Saint John LNG company with the retirement of Courtney Jones. Martin Ugarte has stepped into the role of General Manager coming from his previous role as Operations Manager, and Jose Miguel Moya has moved from Operations Engineer to the Operations Manager role.
- Sergio announced he will be retiring in 2025, no date confirmed as of yet. Gordon Oram will be moving into his role on the CCELC meeting and Lori Grant will be joining for the March meeting also.

There was a question as to whether or not the BOG Project would require registration under an Environmental Impact Assessment (EIA), and how the project impacts would be monitored. Sergio informed the committee that there would be no EIA as there is no significant change in environmental impact (*i.e.*, no additional of water usage, no increase in Greenhouse Gas Emissions, *etc.*). The Project will result in a redundant mechanism that will reduce flaring, further minimizing GHG. Saint John LNG currently report their water usage and emissions through their semi-annual Approval to Operate report, and will continue to do so. Sergio reiterated the Boil Off Gas (BOG) Liquefaction Project will avoid flaring, and will avoid receiving two LNG shipments a year, all of which will reduce the overall greenhouse gas emissions from the Terminal.

Action 128-1 Sergio to put together a presentation for the next meeting that Greenhouse Gas monitoring and reporting requirements the Terminal is subject to.

Q1. (Gordon Dalzell) What is production like so far for SJLNG?

A1. (Sergio Carvana) Had send out last week and expecting two ships in early 2025.

Q2. (Gordon Dalzell) Will the tariffs effect the LNG facility?

A2. (Sergio Carvana) No, when we send out NG it is because we are the only supplier left and it comes at a high cost. SJLNG can send gas out quickly.

Q3. Gordon Dalzell inquired on the thickness of the pipe used at SJLNG and the difference between the pipe used on site and the pipe in the Northeast Pipeline.

A3. Gordon Oram mentioned SJLNG has a High-Pressure pipe and a Low pressure pipe.

David Thompson asked about the plan to build a 400MW natural gas facility in Dieppe. Sergio did not hear any rumors of this.

Q4. Gordon Dalzell asked what tariff structure NB Power applies to the SJLNG facilities.

A4. Gordon Oram explained that the rate is based on 90% of the peak use during the year.

(4) NEW BUSINESS / MEMBERS STATEMENTS

Pam McNeill is interested in how SJLNG manages their Greenhouse Gas emissions (i.e., how they differ from construction till now, what types of Greenhouse Gas are captured in the reports, *etc.*). Sergio will prepare a few slides to include in the monitoring presentation for next month's meeting.
